PARKING GARDEN (2010). IN FY16, WE COMPLETED THE RE-PAVING OF PATHWAYS IN THE GARDEN AND UPGRADED ABOUT HALF OF THE EXTERIOR SIDEWALKS. IN FY17 WE ADDED THE SECOND STEPPED RAMP ALONG THE COLLEGE POINT BOULEVARD BRIDGE. IN FY18 WE COMPLETED AN UPGRADE TO THE GEOTHERMAL HEATING & COOLING SYSTEM AND ADDED A BUILDING MANAGEMENT SYSTEM TO TIE IN THE VARIOUS SYSTEMS INCLUDING HEATING & COOLING, LIGHTING, GREY WATER, AND IRRIGATION TO BRING GREATER EFFICIENCY.
